1. DIRECTOR'S REPORT, Eve Del Real

- a. Eve spoke about the announcement of the release for a COLA (Cost of Living Adjustment) Application. It would be a 1.77 increase, which would equal to a little over \$200,000 for our largest grant.
- b. She also spoke about her visits to some of the classrooms. The reason for these visits is to identify needs and facility improvements that are needed for teachers to be successful in their classrooms.
- c. She announced that Maricopa County Head Start was one of the recipients of the National Head Start Advocating for Policy Change Award.

2. PROGRAM SERVICES OVERVIEW

- **a.** Child Development & Education, Eric Bucher Eric shared information and data about the progress children are making towards school readiness goals, and also what high quality education looks like at Head Start.
- **b. Proposal to Change the Home base Curriculum, Jen Gaulke** Jen had asked the Family Educators what challenges they were facing. Their response was having to add and supplement to the current curriculum they are currently using. They reviewed and compared four curriculums and selected Partners for Healthy Baby to use for the 2019-2020 program year.
- **c. Program Self-Assessment, Eve Del Real** Eve spoked about the self-assessment that is done every year. It is a comprehensive review of how the program is doing. A case study is done on approximately 300 of our files. Policy Council members were asked to volunteer to help with the assessments.
