CRIMINAL JUSTICE SYSTEM Monthly Changes – June 2015

Adult Jail Incarceration

- **Bookings decreased** from 8,879 in May to 8,524 in June.
- **Releases decreased** from 8,680 in May to 8,471 in June.
- The **Average Daily Population (ADP) increased** from 8,130 in May to 8,147 in June.
- The **Pretrial ADP increased** from 6,091 in May to 6,176 in June.
- The **Sentenced ADP decreased** from 1,799 in May to 1,752 in June.
- The **Agency Hold ADP decreased** from 192 in May to 171 in June.
- **Overall Average Length of Stay (ALOS) at release increased** from 26.3 in May to 28.9 in June.
- The **ALOS in days for Pretrial increased** from 8.0 in May to 8.07 in June.
- The **ALOS in days for Sentenced decreased** from 24.04 in May to 22.43 in June.
- The **ALOS in days for Agency Holds increased** from 69.6 in May to 82.3 in June.

Superior Court Filings & Case Processing

- **New Criminal Case Filings increased** from 2,605 in May to 2,699 in June.
- **Case Terminations increased** from 2,272 in May to 2,588 in June.
- The **resulting Clearance Rate** was 96%.
- The **Active Pending Case Inventory increased** from 11,335 in May to 11,448 in June.
- **Regional Court Center filings increased** from 1,327 in May to 1,365 in June.
- **Early Disposition Court filings increased** from 1,009 in May to 1,031 in June.
- The **Number of Trials Completed increased** from 47 in May to 53 in June.
- The **Trial Rate** was 2%.

Justice Court Filings

- **DUI Filings increased** from 715 in May to 747 in June.
- **All other Criminal Traffic Filings increased** from 3,048 in May to 3,299 in June.
- **Civil Traffic Filings decreased** from 10,526 in May to 10,013 in June.
- **Eviction Action Filings increased** from 5,019 in May to 5,635 in June.
- **Total Filings increased** from 27,552 in May to 29,931 in June.

Adult Probation

- **Pretrial Standard Supervision increased** from 2,514 in May to 2,572 in June.
- **Pretrial Electronic Monitoring decreased** from 621 in May to 606 in June.
- **Adult Standard Probation Supervision increased** from 23,039 in May to 23,128 in June.
- **Adult Intensive Probation Supervision decreased** from 1,037 in May to 1,018 in June.
- **Adult Unsupervised Probation Supervision decreased** from 5,081 in May to 4,969 in June.

Juvenile Detention and Probation

- The **Average Daily Detention Population decreased** from 190 in May to 176 in June.
- The **ALOS in juvenile detention increased** from 15.7 in May to 23.2 in June.
- **Juvenile Standard Probation increased** from 1,925 in May to 1,928 in June.
- **Juvenile Intensive Probation increased** from 242 in May to 251 in June.
- **Monthly commitments to Arizona Department of Juvenile Corrections increased** from 18 in May to 19 in June.





Number of Dependency Petitions Filed Juvenile Court





Recidivism Risk Score (RRS / "Proxy") Distribution Among Current Jail Population:






Jail Releases




Average Daily Jail Population



Average Daily Jail Population by Type




Average Daily Jail Population by Gender




Average Daily Jail Population Charges by Gender within Specific Populations

Pretrial Distribution




Sentenced Distribution




Pretrial Average Daily Population




Pretrial Felony Average Daily Population




Pretrial Misdemeanor Average Daily Population




Sentenced Average Daily Population




Average Daily Jail Population of City Offenders



Overall Average Length of Stay in Jail at Release




Overall Average Length of Stay in Jail In Custody*




Average Length of Stay in Jail Pretrial and Sentenced Inmates




Average Length of Stay in Jail for Pretrial Inmates



Average Length of Stay in Jail for Sentenced Inmates




Average Length of Stay in Jail Agency Holds





Sheriff's Office Transports for Inmate Court Appearances






Active Pending Criminal Case Inventory



Direct Complaints into Superior Court




Superior Court Trials Completed



Status of Cases After 180 Days




Disposition of Cases Terminated




Grand Jury Indictments








Justice Court Monthly Filings - Quarterly Average




Pretrial Supervision Defendant Monitoring Unit Average Daily Standard Caseload




Adult Probation Department Standard Supervision




Adult Probation Intensive Supervision




Adult Probation Unsupervised Population



Juvenile Detention Average Daily Population




Juvenile Detention Average Length of Stay




