I. ORDINANCES

ORDINANCE NO. P-30 (Passed and Adopted)

Summary: Referred to and known as “Ordinance for Establishing Licensing Time Frames,” this ordinance establishes both administrative and completeness review and substantive review time frames for Licenses as defined in A.R.S. § 11-1601 through A.R.S. § 11-1605.

ORDINANCE NO. P-31 (Passed and Adopted)

Summary: Referred to and known as “Ordinance Establishing Fees Related to Licensing Time Frames,” this ordinance establishes the fees referenced in Exhibit B – Fees of the Maricopa County Ordinance Licensing Time Frames in Compliance with A.R.S. § 11-1601 through A.R.S. § 11-1610, No. P-30.

II. REGULATIONS

Maricopa County Environmental Health Code

Chapter I – General Provisions

Summary: Sets forth legal authority for Environmental Health Code. Includes definitions used throughout the Environmental Health Code and describes the permit process, fees, right to inspection and enforcement tools.

Chapter II – Sewage and Waste

Summary: Describes sewage and waste provisions including permit requirements and application procedures, proper refuse collection, storage and disposal, classification of wastewater treatment plants and requirements for certified operators.

Chapter III – Rodents, Insects and Vermin

Summary: Describes requirements to prevent infestation or harborage of rodents, insects, and vermin, and breeding of mosquitoes. Also describes enforcement tools.

Chapter IV – Land Subdivisions

Summary: Describes requirements for land subdivisions including plan approval, condominiums, water supply, sewage disposal and refuse disposal.

Chapter V – Water Supply

Summary: Describes requirements for water supplies including permit requirements and hauled water.

Chapter VI – Bathing Places – Public and Semipublic Swimming Pools

Summary: Describes requirements for Public and Semipublic pools and spas, Natural and Semi-Artificial Bathing Places and Artificial Bathing Lakes including permit requirements, water quality standards and general design standards.

Chapter VII – Food Employees/Certified Food Protection Managers

Summary: Describes requirements for Food Employees and Certified Food Protection Managers.

Maricopa County Environmental Health Code (*continued*)

Chapter VIII – Food, Food Products, Food Handling Establishments

Summary: Describes requirements for Food, Food Products and Food Handling Establishments including Mobile Food Establishments, Vending Machines, Meat Establishments, Food Related Facilities and Bottled Water.

Chapter IX – Mobile Home Parks

Summary: Describes requirements for Mobile Home Parks including general layout, facilities, water supply and sewage disposal.

Chapter X – Residence Accommodations

Summary: Describes requirements for Residence Accommodations including Transient Dwelling Establishments.

Chapter XI – Animals

Summary: Describes requirements for Animals including Kennels, Pet Shops, Veterinary Clinics and Hospitals and Mobile Pet Groomers/Shops.

Chapter XII – Campgrounds

Summary: Describes requirements for Campgrounds including permit requirements, water supply and sewage and refuse disposal requirements.

Chapter XIII – Schools

Summary: Describes requirements for Schools including permit and plan requirements.

Chapter XIV – Indoor Play Area

Summary: Describes requirements for Indoor Play Areas on the premises of permitted Food Establishments when the primary function of the business or facility is food service to the general public.

Maricopa County Stormwater Quality Management and Discharge Control Regulation (“Regulation”)

Chapter 1 – Introduction

Summary: Sets forth legal authority for the Regulation, minimum permit requirements for the County and the purposes and objectives of the Regulation.

Chapter 2 – Rules of Construction and Interpretation

Summary: Describes requirements for County Permits and Approvals, also includes general statements regarding responsibility of Administration, compatibility with other regulations, other regulatory requirements, severability, and disclaimers.

Chapter 3 – Definitions

Summary: Includes definitions of terms used in the Regulation.

Chapter 4 – Applicability

Summary: Describes the applicability of the Regulation.

Maricopa County Stormwater Quality Management and Discharge Control Regulation (“Regulation”) (*continued*)

Chapter 5 – Illicit Non-Stormwater Drainage and Connections

Summary: Describes the requirement to prohibit Non-Stormwater Drainage and Illicit Connections to the County Municipal Separate Storm Sewer System or any Storm Drainage System.

Chapter 6 – Construction Site Stormwater Runoff Pollution Control

Summary: Describes the requirements for the regulation of construction sites, exemptions, transfers of approval, termination of coverage and compliance monitoring.

Chapter 7 – Industrial Activity Discharges

Summary: Describes the requirement for the submission of the Notice of Intent or other proof of compliance to the Department.

Chapter 8 – Requirement to Prevent, Control and Reduce Stormwater Pollutants by the Use of Best Management Practices

Summary: Describes the requirement to implement Best Management Practices for Stormwater.

Chapter 9 – Notification of Spills

Summary: Describes the requirement to notify the Department in the event of a release of pollutants into the County Municipal Separate Storm Sewer System or any Storm Drainage System.

Chapter 10 – Violations, Enforcement, Penalties and Authority

Summary: Describes enforcement tools.

Chapter 11 – Post-Construction Stormwater Management

Summary: Describes requirements including applicability, objectives, regulated activities, exemptions, waivers, design standards, plan approval, ownership and maintenance, operation and maintenance plans, Drainage Regulation and Flood Control Regulations.

Chapter 12 – Fees

Summary: Fee list for Stormwater Permitting and Approval Activities.

Chapter 13 – Effective Date and Adoption of Regulation

Summary: Lists the effective date and the Board of Supervisor adoption information.

Summary: Clarifies where the regulations from MCEHC, Chapter 8 (Food, Food Products, Food Handling Establishment) will be applied in Boarding Homes.

Summary: Clarifies the plan review procedure to approve additional food establishment permits, which are under the same ownership on the premises.

Summary: Clarifies the requirements for Special Event Food Establishments to operate at farmers markets, swap meets, and sanctioned school functions.

Summary: Clarifies the health hazards that shall be addressed in pet shops.

Summary: Clarifies how many inspections are included with a New Business Permit Application.

Summary: Clarifies which types of food establishments are exempt from Certified Food Protection Manager Card requirements.
